I, on behalf of my self, my personal representative and my heirs hereby voluntary agree to release, waive, discharge, hold harmless, defend and indemnify *GWRRA*, and its members, employees, agents, representatives, officers, staff or volunteers from any and all claims, suits or causes of action for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my participation in the *GWRRA* Road Captain Course training. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by *GWRRA* members, employees, agents, representatives, officers, staff or volunteers and those governmental agencies and other organizations affiliated with this course.
